CLARIFICATION * AT&T POLICY ON FINANCIAL PLANNING SEMINARS AND WORKSHOPS (8/8)** – Yesterday's AT&T TODAY item noted that financial planning seminars and workshops are not sponsored or endorsed by AT&T unless the announcement or invitation comes directly from AT&T via a company publication. **There is one exception, however:**

financial planning classes provided through the Alliance for Employee Growth and Development, a partnership between AT&T, the Communications Workers of America and the International Brotherhood of Electrical Workers. These Alliance courses are designed solely to educate employees on financial planning and do not attempt to sell products or services. The Alliance is authorized to use AT&T facilities to conduct various types of training, including financial planning, with AT&T's support and endorsement. The AT&T policy described in yesterday's edition applies to employees who are contacted by outside financial planning firms that request to hold seminars or workshops on company premises.
